The Republic of Uzbekistan has received financing from the Asian Infrastructure Investment Bank (AIIB or the Bank) toward the cost of the **Bukhara Region Water Supply and Sewerage Project (Phase 1)** and intends to apply part of the proceeds toward payments under the following contracts for **Construction and Reconstruction Works for the Water Supply System in the Romitan District of Bukhara Region (Lot 1 & 2)**. Tendering process will be governed by the Bank’s Procurement Instructions for Recipients;
2. The JSC Bukhoro Suv Taminoti now invites sealed Tenders from eligible Tenderers for Construction and Reconstruction Works for the Water Supply System in the Romitan District of Bukhara Region (**Lot No 1 & 2**). The works include mainly construction/reconstruction of water reservoirs, pumping stations, water distribution network and transmission pipelines as summarized below.

Lot No 1: Main Water Transmission Line, Arabon & Utabek WDUs, Water Pipelines and Water Supply Networks

3. Tendering will be conducted through International Open Competitive Tendering procedures as specified in the Bank's Procurement Instructions for Recipients (PIR) and is open to all eligible Tenderers as defined in the PIR;
