- The People's Republic of Bangladesh has received for financing from the Asian Infrastructure Investment Bank (AIIB) toward the cost of Bangladesh Power System Upgrade and Expansion (Chattogram Area) Project. Part of this financing will be used for payments under the contract named above. Tendering is open to Tenderers from eligible countries described in the Tendering Document.
- 2. The Power Grid Company of Bangladesh Limited (PGCB), ("the Employer") invites sealed tenders from eligible tenderers for the "Design, Supply, Installation, Testing & Commissioning of Anowara-Ananda bazar (New Mooring) 400kV Transmission Lines (Package-1)" (hereinafter referred to as "the Works"). The Works under this turnkey contract shall have to be completed within 720 (Seven hundred twenty) days from the effective date.
- 3.International Open Competitive Tendering (IOCT) will be conducted in accordance with AIIB's Interim Operational Directive on Procurement Instructions for Recipients (June 2, 2016) (PIR) and is open to all prospective Tenderers from all eligible countries as described in the Tendering Document.
- 4.Tenderers shall meet the following minimum requirements along with other requirements as mentioned in the tendering documents:
- (a) Experience under contracts in the role of contractor, subcontractor or management contractor in power sector for at least 10(ten) years prior to the Tender submission deadline.
- (b) Participation as a Contractor in at least three contracts that have been successfully completed within the last 10 (ten) years, and those are similar to the proposed contract, where the total route length of the line for these contracts must be at least: 60 km (Sixty kilo-meters)

The similarity of the Tenderer's (or JV partner) participation shall be based on the physical size, nature of works, complexity, methods, technology or other characteristics as described in Employer's Requirements.

For the above mentioned contracts executed during the period mentioned above:

- (i) at least one (1) of the above contract shall be of 345kV or higher voltage rating transmission line (i) having at least 20 km route length of single/double circuit line and where the value of the Tenderer's (or JV partner) participation in the contract exceeds: USD 10.000.000 (ten million USD) and (ii) the scope of works include supply, Installation, Testing & Commissioning
- (ii) at least one (1) contract shall be of 345kV or higher voltage rating transmission line (i) having at least 20 km route length of single/double circuit line and (ii) scope of works include Design, Supply, Installation, Testing & Commissioning.

- (iv) at least one (1) contract shall be of 345kV or above voltage transmission line (i) having at least 20 km route length and (ii) completed outside the tenderer's own country.

Evidence of above experience shall be submitted in the tender. It shall be given on the user's letter- head, indicating address, telephone and fax numbers of the user. It shall include the name of the project, name of the employer, description of the work, commissioning date and contract amount.
