The Government of the People's Republic of China has applied for a loan from the Asian Infrastructure Investment Bank (hereinafter referred to as "AIIB") to finance the Henan Flood Emergency Rehabilitation and Recovery Project ("the Project") and intends to utilize a part of the loan for the Management Information System Development, Operation and Maintenance Consulting Services.

The Management Information System Development, Operation and Maintenance Consulting Services ("Services") include the design and development of the Project Management Information System according to the construction contents, management system and process of Henan Flood Emergency Rehabilitation and Recovery Project, which is to manage the plan preparation (including the project investment budget, annual investment plan and procurement plan), contract procurement and implementation, project progress and financial progress monitoring, performance monitoring, financial management, withdrawal, reimbursement and payment information in the process of project implementation, and further to realize the information reporting level by level and multi-level information sharing, and finally to improve the efficiency and standards of the project management. The Zhengzhou, Xinxiang and Jiaozuo Municipal Financial Bureaus (Municipal Project Management Offices), the Henan Provincial Financial Department (Provincial Project Management Office), the relevant county/city Financial Bureaus, the Project Implementing Units of water conservancy, transportation, urban-rural housing and development and emergency

management sectors and other related county/city Project Implementing Units together with all the Contractors and Supervision Companies involved in the project construction will adopt the Management Information System in the process of project implementation for project management or data report. The services are expected to start in 2022 and end in 2025.

Project Management Office for the Henan Flood Emergency Rehabilitation and Recovery Project – Xinxiang Component now invites eligible Consultants to submit their Expression of Interest in providing the Services. Interested Consultants shall provide related information and documents demonstrating that they have the required qualifications and relevant experience to perform the Services. The following qualifications will be considered as the criteria in shortlisting Consultants:

- i) shall have successfully developed and implemented at least two (2) similar projects with management information system (providing copies of contracts) in the last 5 years (December 2016 to December 2021); Priority will be given to the Consultants with experience in development and maintenance of project management information system for projects financed by international financial organizations.
- ii) shall have capacity to mobilize a technical team with rich experience for the execution of the assignment.

The joint venture is not acceptable to this assignment.

Documents required include the following, but not limited thereto:

- i) Legal name of the Consultant and its business licenses;
- ii) Contact person and details (address, phone numbers, and email address);
- iii) Consultant's general profile, or brochures;
- iv) Description of its organization structure, staffing situation and facilities;
- v) General listing of performed projects for the last ten years, including the completed and the on-going projects;
- vi) Other documentation as Consultant finds necessary to demonstrate its capability and competency to perform the assignments.

The attention of interested Consultants shall be drawn to article 5.9 of the Asian Infrastructure Investment Bank's *PROCUREMENT POLICY* dated January 2016 and related policy on conflict of interest set force in *INTERIM OPERATIONAL DIRECTIVE ON Procurement Instructions for Recipients* dated June 2, 2016.

A Consultant will be selected in accordance with the Quality Cost Based Selection (QCBS) method as described in the Asian Infrastructure Investment Bank's *INTERIM OPERATIONAL DIRECTIVE ON Procurement Instructions for Recipients*.
