To improve irrigation service delivery, strengthen flood risk management and improve climate change resilience in the project area.

5. Project Implementation Update

The Project has made a substantial progress in preparing bidding documents and in awarding contracts for civil works. A little over 6 months after the Project Effectiveness and despite restrictions due to Cyclone Amphan and COVID-19, the Project has awarded 20 flood protection and 17 irrigation civil works contracts (in 6 and 10 work packages, respectively) amounting to about USD 238 million in total, which represents nearly 60 percent of the total Project financing.

Restrictions due to the COVID-19 have eased and all civil works have resumed. However, due to the COVID-19 lockdown and the recent Cyclone Amphan, the progress of all civil works has been delayed. The last implementation support mission noted that the Project has been further challenged by the slow releases of counterpart funds and delays in the certification and payment of contractors' invoices by the CPMU. Actions have been identified and agreed with the CPMU, which



are aimed towards (i) timely submission, certification, and payment of invoices, (ii) timely releases of adequate funds and (iii) tightening construction supervision. Also, it was agreed that a contract management plan will be prepared, which will include KPIs to monitor contract implementation and assess the performance of contractors. This will help ensure that contract closing dates and contract extensions are closely monitored.

Financial Management:

The Project has been facing fund flow constraints throughout the financial year 2020-21 with the Department of Finance (DOF), GoWB releasing INR 58 crores (US\$ 8 million equivalent) less than requested. Due to this, there exists a mismatch in the physical and financial progress across all civil works contracts. The last mission discussed with DOF to ensure that adequate funds are released on a timely manner so that Project activities can be implemented without delay. The DOF informed that INR 190 crores (US\$25 million equivalent) was released on March 8, 2021.

The IUFRs have been submitted on timely basis and no major issues noted.

The Office of the Accountant General of West Bengal has initiated the audit of the Project expenditures for the financial years 2018-19 and 2019-20 and the audited Project financial statements are expected to be submitted to the Bank by April 30, 2021.

6. Status of the Grievance Redress Mechanism (GRM)

A GRM has been established. Six grievances have been received and resolved so far.

7. Results Monitoring

The project is in its early phase of implementation. The TOR of Monitoring and Evaluation (M&E) consultant is being finalized. M&E consultant is expected to be onboard by end of Q2 / beginning of Q3 2021.
